

ON AUG 21 2019 POLICE RESPONDED TO A CALL FOR SERVICE AT 3816 SYFERT LN AND SPOKE WITH OP 1. DURING THE INCIDENT OP 1 MADE STATEMENTS THAT HER BOYFRIEND (SUSPECT) WAS BUILDING BOMBS IN THE RV TRAILER AT HIS RESIDENCE. WHILE ON THE SCENE OF 3816 SYFERT LN POLICE ALSO SPOKE WITH OP 2. OP 2 STATED THAT HE IS AN ATTORNEY WHO REPRESENTS OP 1 AND THE SUSPECT AND THAT THE SUSPECT FREQUENTLY TALKS ABOUT THE MILITARY AND BOMB MAKING. HE STATED THAT HE BELIEVES THAT THE SUSPECT KNOWS WHAT HE IS DOING AND IS CAPABLE OF MAKING A BOMB.

POLICE THEN RESPONDED TO THE SUSPECT'S RESIDENCE AT 115 BAKERTOWN LN. POLICE KNOCKED ON THE DOOR BUT DID NOT RECEIVE AN ANSWER. POLICE OBSERVED THAT THERE WAS A RV TRAILER IN THE BACK YARD BUT THE YARD WAS FENCED OFF AND POLICE COULD NOT SEE INSIDE THE RV. POLICE ALSO OBSERVED THAT THE LOCATION HAS SEVERAL SECURITY CAMERAS AND WIRES ATTACHED TO A ALARM SIGN ON THE FRONT DOOR. POLICE ATTEMPTED SEVERAL TIMES BUT COULD NOT GET THE SUSPECT TO OPEN THE DOOR AND POLICE DID NOT HAVE CONTACT WITH HIM.
