Subject: Requirement to Delete the Tennessee Board of Medical Examiners' Statement on
Medical Misinformation or Disinformation Regarding COVID-19 or Appear
Before the Joint Government Operations Committee to Explain Inaction

President Blake:

1. This communication emphasizes your organization's requirement to promptly delete reference c., above, not later than 29 November 2021. Governor Lee signed the bill containing references a. and b., above, on 12 November 2021, making these sections, among others, law immediately. If you fail to act promptly, your organization will be required to appear before the Joint Government Operations Committee to explain your inaction.

2. Reference a., above, defines adverse action. References b., h., and i., above, make it clear that adverse actions that "affect private rights, privileges or procedures available to the public" must be put in place via rule making processes specified in title 4, chapter 5 of the T.C.A.


3. For purposes of clarity, reference b., above, is herewith quoted: “Notwithstanding title 63 or 68 to the contrary, any disciplinary process, or action taken pursuant to such process, that is implemented by a health-related board regarding the dispensing or prescribing of medication for COVID-19 must be promulgated as a rule pursuant to title 4, chapter 5.”

4. Please note that giving a patient information during the dispensing or prescribing of medication for COVID-19 is medically essential. However, such can create a potential conflict with reference c., above. Regrettably, your organization has not defined the title terms of reference c., above. Therefore, your organization’s public posting of reference c., above, creates a conflict with reference b., above. Consequently, this situation requires you to promptly delete reference c., above, until an appropriate rule can be promulgated pursuant to title 4, chapter 5 of the T.C.A.

5. Reference g., above, indicates that you do not plan to even consider action until January of 2022. Such delay is unacceptable given the issue was brought to your attention in reference d., above, three weeks ago. Moreover, reference d., above, was dispatched to you 13 days prior to the 3 November 2021 meeting of your board, giving ample time for adding it to the agenda for action.

6. In summary, your organization must delete reference c., above, without delay. Such immediate action is required by laws newly in effect. If you fail to act promptly, your organization will be required to appear before the Joint Government Operations Committee to explain your inaction.
